That, subject to the passing of resolution 4 above and in accordance with section 570 of the CA 2006, the Directors be generally empowered to allot equity securities (as defined in section 560 of the CA 2006) pursuant to the authority conferred by this resolution, as if section 561(1) of the CA 2006 did not apply to any such allotment, provided that this power shall:
  - Be limited to the allotment of equity securities up to an aggregate nominal amount of £50,000; and expire 31<sup>st</sup> January 2023 (unless renewed, varied or revoked by the Company prior to or on that date), save that the Company may, before such expiry make an offer or agreement which would or might require equity securities to be allotted after such expiry

and the Directors may allot equity securities in pursuance of any such offer or agreement notwithstanding that the power conferred by this resolution has expired.

- 5. That Paul Clegg & Company be appointed as Auditors of the Company.
- 6. That the Board be authorised to settle the remuneration of the Auditors for 2022.
- 7. To transact any other business which may properly be transacted at an Annual General Meeting, any matters to be raised under any other business should be lodged in writing to the Registered Office no later than 48 hours prior to the meeting date.
